

VOLUNTEER AGREEMENT AND RELEASE FROM LIABILITY

1. I, _____ agree to work for Bridge Street Mission as a volunteer. My volunteer activities will include, but are not necessarily limited, to doing the following on or off the mission grounds _____.

2. As a volunteer, I understand that I control the dates and times when I do the work and that Bridge Street Mission is not responsible for scheduling my volunteer work. I also understand that I will not be compensated for any time spent volunteering, nor am I entitled to benefits, including employment insurance benefits upon the termination of this agreement or as a result of this service.
3. I am aware that participation as a volunteer may require periods of standing, lifting and carrying up to 40 pounds and will require the exercise of reasonable care to avoid injury. I am voluntarily participating in this activity with knowledge of the hazards and potential dangers involved, and agree to accept any and all risks of personal injury and property damage.
4. As consideration for volunteering for Bridge Street Mission, I hereby agree that I, and my assignees, heirs, guardians, and legal representatives, will not make a claim against or sue Bridge Street Mission or its employees, agents or contractors for injury or damage resulting from the negligence, whether active or passive, or other acts, however caused, by any of its officers, employees, agents, or contractors of Bridge Street Mission as a result of my volunteering. I HEREBY RELEASE AND DISCHARGE BRIDGE STREET MISSION AND ITS OFFICERS, EMPLOYEES, AGENTS AND CONTRACTORS FROM ALL ACTIONS, CLAIMS, OR DEMANDS THAT I, MY HEIRS, GUARDIANS, AND LEGAL REPRESENTATIVES NOW HAVE, OR MAY HAVE IN THE FUTURE, FOR INJURY OR DAMAGE RESULTING FROM MY PARTICIPATION IN THE PROJECT.
5. I UNDERSTAND THAT IF I AM INJURED IN THE COURSE OF THE PROJECT, I AM NOT COVERED BY BRIDGE STREET MISSION'S WORKERS' COMPENSATION PROGRAM. I authorize Bridge Street Mission to seek emergency medical treatment on my behalf in case of injury, accident or illness to me arising from my involvement as a volunteer. I understand that I will be responsible for medical costs incurred by such accident, illness or injury.
6. I understand that the materials and tools provided by Bridge Street Mission are and remain the property of Bridge Street Mission, and I agree to return these tools and any remaining materials to Bridge Street Mission at the end of my volunteer service.

7. I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS.
